East Sussex County Council is consulting on its draft Local Flood Risk Management Strategy between **29 February 2016** and **10 April 2016**.

We would like your views to ensure that the strategy is locally relevant, appropriate and understandable.

The County Council is the Lead Local Flood Authority (LLFA) for East Sussex under the Flood and Water Management Act (2010). The Strategy sets out how we plan to manage the effects of local flooding across the county over the next 10 years.
